The audit is based on a standard promulgated by the American Institute of Certified Public Accountants (AICPA). It is widely recognized as representing that a service organization has been through an in-depth audit of its control objectives and activities, which often encompass Information Technology (IT) and related business processes. In deeming a company's successful SAS 70 Type II audit, the auditor expresses opinions against various criteria including whether the company presents its controls fairly, whether those controls were suitably designed to achieve specified control objectives, and whether they were tested and found to be operating with sufficient effectiveness to provide reasonable assurance that the control objectives were achieved during the specified period.

For PCI Group, the SAS 70 Type II audit is evidence of the company's emphasis on and adherence to high quality assurance standards. Within the highly regulated collection industry, this attribute weighs heavily in an agency's selection of its direct mail service provider. Now, in addition to being able to tout its leading-edge technology when marketing its services, PCI Group can also cite this noteworthy certification.
